And whereas it appears to us as will upon the oath of Henry Atfield as otherwise that neither they the said Henry Atfield Jane his wife, Henry, John, William, James, Richard, Jane, Thomas, Edmund their children nor any of them have gained any legal settlement since the date of the said certificate whereby and upon due consideration had of the premisses it appears to us and we do hereby adjudge that the said Henry Atfield Jane his wife and Henry, John, William, James, Richard, Jane, Thomas and Edmund their children are become chargeable to the said Parish of Weybridge and that the place of their last legal settlement of them and every of them is in the said Parish of Windlesham in the said County of Surrey. These are therefore to require you the said Churchwardens and Overseers of the Poor of the said Parish of Weybridge or some or one of you to convey the said Henry Atfield with Jane his wife and Henry, John, William, James, Richard, Jane, Thomas and Edmund their children from and out of your said Parish of Weybridge to the said Parish of Windlesham and them to deliver to the Churchwardens and Overseers of the Poor there or to some or one of them together with this our Order or a true copy thereof at the same time showing them the original And we do also hereby require you the said Churchwardens and Overseers of the Poor of the Parish of Windlesham to receive them and provide for them as Inhabitants of your Parish
